# DEPARTMENT OF DEFENSE OFFICE OF THE UNDER SECRETARY OF DEFENSE FOR POLICY CLOSED MEETING REPORT of the DEFENSE POLICY BOARD

# Under Section 10 (d) of the Federal Advisory Committee Act

The Defense Policy Board (DPB) met on September 11 and 12, 2023, at the Pentagon, Arlington, Virginia. The objective of the meeting was to receive classified briefings and hold classified discussions to understand the long-term impact of hypothetical People's Republic of China coercion across the Taiwan Strait to regional and global strategic interests, including implications for U.S. alliances in the Indo-Pacific and around the world. The Acting Under Secretary of Defense for Policy addressed the DPB, and the Secretary and Deputy Secretary of Defense attended the outbrief from the Board. The Board received briefings from senior officials of the Department of Defense, the Department of Commerce, and the Federal Reserve. The meeting was closed to the public pursuant to the provision of Section 552(b)(c)(1), Title 5, United States Code. The determination was based on the consideration that the discussion involved classified information.
